1. STANDING ORDERS AND DIRECT DEBITS

Standing orders

Standing orders are realised on contracted date of payments under the assumption that the account holds sufficient balance for execution of payments.

Bank will realise the standing order on the contracted date of payment, on business days

(Monday-Friday) until 12:30 p.m.

In case the date of payment is not a business day (Saturday, Sunday, public holiday or religious holiday), payment shall be realised on the first next business day after the contracted date .

User is obliged to provide funds on the account at the latest a day earlier than the date set as the contracted date of payment.

Direct debits

The Bank will execute orders based on Direct Debits on business days (Monday-Friday), based on the order initiated by the payee. The User is obliged to provide funds in the account no later than 10:00 a.m. on the due date of the obligation based on the Direct Debit Authorization

2. OTHER PROVISIONS OF THE SCHEDULE

For Orders received by the Bank after the defined deadline, the date of receipt is the next business day. Saturday is not a business day for the execution of external orders received at the Bank's counter. External orders received on Saturday are executed at the earliest with a value date of Monday, i.e., the first following business day. Saturdays and Sundays, as well as holidays in the Republic of Serbia, are not considered business days.

The date of payment means the date of payment to the recipient's account.

A payment order cannot be revoked in case it was executed in an interbank transfer.

This fee schedule has been valid since 1.7.2021.
